

The Course at Yale

ANNUAL MEMBERSHIP • MARCH 1 – DECEMBER 31, 2011

Annual full membership includes:

- Reserved member-only tee times
- Advanced tee reservation access
- Guest privileges
- A USGA handicap
- Participation in Yale Golf Club events
- Capital assessment

Members are required to pay a yearly food and beverage minimum of \$150 for single, \$300 for family. Members can use their minimum in either Widdy's or the 9th tee grille.

FULL MEMBERSHIPS:

(For alumni, clinical faculty, fellows, associate fellows and non-Yale affiliate.)

Provides unlimited playing privileges at no additional cost.

INDIVIDUAL \$5,350

FAMILY \$7,150

(For individual, spouse or domestic partner and children under 18 years of age living at home, or children under 22 years of age attending a full-time accredited college.)

FACULTY | STAFF

(For individuals working 20 hours or more as a permanent, benefit-level employee of the University or medical school residents.)

Individual \$2,550

Family *(as defined above)* \$3,400

STUDENT

(For individuals currently enrolled as a full- or part-time student.)

Individual \$1,200

Family *(as defined above)* \$2,050

3 MONTH STUDENT

(For full-time college or high school students under the age of 22.)

June, July, August only \$500

Note: Student members must be capable of playing the course under the pace of play guidelines.

RETIREE MEMBERSHIPS:

(For individuals who have reached age 65 and are fully retired.)

FACULTY | STAFF *(as defined above)* \$1,975

ALUMNI | CLINICAL FACULTY | NON-YALE
(as defined above) \$3,925

Spouse or domestic partner may join the golf course as an individual member if the affiliated individual does not wish to join.

15-ROUND MEMBERSHIPS:

(For alumni, faculty, staff, non-Yale, their spouse or domestic partner.)

Provides 15 rounds of golf per calendar year that may be used at any time including member-only reserved tee times. The rounds can also be used for accompanied guests. Geographic restrictions do not apply.

Alumni *(Golf only)* \$880

Alumni *(Includes Handicap & YGC)* \$950

Faculty / Staff \$660

Non-Yale \$1,210

Limited round access members do not receive advanced access to the tee reservation system.

30-ROUND MEMBERSHIPS:

(For alumni, faculty, staff, non-Yale, their spouse or domestic partner.)

Provides 30 rounds of golf per calendar year that may be used at any time including member-only reserved tee times. The rounds can also be used for accompanied guests. Geographic restrictions do not apply.

Alumni \$2,270

Faculty / Staff \$1,790

Non-Yale \$2,990

These fees include an assessment charge. Limited round access members do not receive advanced access to the tee reservation system.

A USGA Handicap and play in YGC events are not included in Limited Round Memberships. Handicap is \$25 extra. Yale Golf Club is \$75 extra.

2-ROUND ALUMNI GIFT MEMBERSHIPS:

(For alumni, their spouse or domestic partner.)

Provides 2 rounds of golf per calendar year, and includes a \$200 tax-deductible gift.

All Limited Access members participating in the Yale Golf Club events will be required to use 1 round per day for each event. When your rounds are completed, your tee time reservation access will be inactivated.

Unused rounds cannot be carried to the following year. After rounds are used; regular daily and full guest rates apply.

These limited round memberships are individual and cannot be shared.

CORPORATE MEMBERSHIPS:

(For corporations and businesses that will elect, for membership, four individuals within the corporation or business.) The four individuals will be entitled to unlimited play. (Alternatively, the corporation can elect to purchase 300 rounds, within the calendar year, for use by its employees and guests.)

ALUMNI PATRON PROGRAMS:

The patron program is designed to appeal, primarily, to those Yale Alumni who are interested in the future of the classic C.B. Macdonald golf course but who are unlikely to have more than an occasional opportunity to return and to play the course. A patron will be asked to contribute a minimum of \$1,000 (tax deductible) per year for the benefit of The Course at Yale. Patrons will be provided with a private, patron-only tee time reservation hotline, whereby they may reserve in advance, tee times for themselves and guests or up to four unaccompanied guests. The prevailing applicable green and cart fees will be payable. Tee time reservations will be guaranteed subject to scheduled tournaments, outings, and rare course closings due to inclement weather. The patron program will provide important support for special projects required to bring the condition of the course to the standard that a course of its pedigree needs and deserves. Patrons will receive a unique bag tag to acknowledge their participation in the program.

All memberships are due in one payment and must be paid prior to access to the course. Checks, cash, AMEX, Visa, or Master Card are accepted for all memberships. On receipt of payment, new members will receive an engraved membership bag tag, which will entitle the member to use the course. The identification tag must be displayed prominently on the member's bag at all times. If your dues are not paid in full, you must pay a daily fee which is non-refundable.
